## HUNGARIAN VICTIMS OF TRAFFICKING ABROAD

Hungary is a country of origin and transit for victims of trafficking (VoTs) within the European Union. According to the TIP Report (2021), human traffickers exploit domestic and foreign victims in Hungary, and traffickers exploit victims from Hungary abroad.

Vulnerable groups include Hungarians in extreme poverty, undereducated young adults, Roma, single mothers, asylum-seekers, unaccompanied children, and homeless men. Traffickers exploit Hungarian women, boys, and girls in sex trafficking within the country and abroad, mostly within Europe, with particularly high numbers in Germany, Austria, Switzerland, and the United Kingdom (UK).

Traffickers exploit Hungarians in labour trafficking in agriculture, construction, hospitality, and factories domestically and abroad, particularly in Belgium, the UK, and the Netherlands.

Approximately 23,000 Hungarian children live in state-run childcare institutions who are vulnerable to trafficking. Many child sex trafficking victims exploited within the country and abroad come from state-run institutions and correctional facilities, and traffickers recruit them when they leave these institutions.

## NATIONAL CRISIS MANAGEMENT AND INFORMATION TELEPHONE SERVICE (OKIT)

For victims of human trafficking, the National Crisis Management and Information Telephone Service (OKIT) can also provide more information on available legal, administrative, housing and other forms of assistance at +36 80 205 520. This phone number is free to call from Hungary 24 hours a day, 7 days a week.

OKIT also helps victims to use the services of the victim support system, they refer VoTs to specialized shelters. The purpose of these accommodations created and maintained specifically for victims of human trafficking is to provide complex, comprehensive assistance in rehabilitation and reintegration to severely traumatized and exploited victims with the help of professionals (lawyers, psychologists or mental health specialists, social workers).
